ORDINANCE NO. 1964

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF DAYTON, WASHINGTON, AUTHORIZING AN AMENDMENT TO ORDINANCE NO. 1958, ADOPTING THE 2020 CITY OF DAYTON BUDGET, TO INCLUDE BUDGET AMENDMENT 2020-01.

WHEREAS, the City of Dayton adopted the 2020 Budget ("Budget") in final form by Ordinance No. 1958 on the 4th day of December, 2019; and

WHEREAS, it has become necessary to amend the Budget to account for 2020 Beginning Fund Balances, intrafund transfers from the Water Revenue Fund and Sewer Revenue Fund in support of the Water and Sewer System Debt Service Fund for payment of water and sewer debt obligations, and Affordable and Supportive Housing Fund revenues.

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF DAYTON, WASHINGTON DO HEREBY ORDAIN AS FOLLOWS:

SECTION 1. AMEND. The City of Dayton 2020 Budget is hereby amended **to change resources and appropriations** as set forth below:
