### **ORDINANCE NO. 1992**

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF DAYTON, WASHINGTON AMENDING ORDINANCE 1568 AND SECTION 9-47.04 OF THE DAYTON MUNICIPAL CODE, DOMESTIC VIOLENCE PROTECTION ORDER STATUTES INCORPORATED BY REFERENCE; AND PROVIDING FOR SUMMARY PUBLICATION BY ORDINANCE TITLE ONLY

WHEREAS, RCW 35.21.180 authorizes the City to adopt Washington State ordinances by reference as if herein set forth; and

WHEREAS, pursuant to the grant of authority at RCW 35.21.180, the City Council adopted Ordinance 1568 at a regular meeting on June 14, 1994, adopting statutes related to domestic violence protection orders by reference, including RCW 26.50.010 and 26.50.110; and

**WHEREAS**, the Washington State Legislature repealed the entirety of Chapter 26.50 RCW and replaced it with Chapter 7.105 RCW.

# NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF DAYTON, WASHINGTON, DO HEREBY ORDAIN AS FOLLOWS:

<u>Section 1</u>. Ordinance 1568 and Section 9-47.04 of the Dayton Municipal Code are hereby amended as follows:

<u>Section 3.</u> Should any section, paragraph, sentence, clause, or phrase of this Ordinance be held invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause, or phrase of this Ordinance.

Section 4. A summary thereof of this Ordinance consisting of its title shall be published in the official newspaper of the City. This ordinance shall take effect and be in full force five (5) days after the date of publication.
