

RESOLUTION NO. 1446

**A RESOLUTION OF THE CITY OF DAYTON, WASHINGTON,
AUTHORIZING THE CITY TO ENTER INTO AN INTERLOCAL AGREEMENT
FOR LAW ENFORCEMENT SERVICES, DISPATCH SERVICES, AND
MUNICIPAL COURT SERVICES WITH COLUMBIA COUNTY**

WHEREAS, Columbia County provides law enforcement services, dispatch services and municipal court services to the City of Dayton pursuant to interlocal agreements; and

WHEREAS, the interlocal agreements for law enforcement services, dispatch services, and municipal court services have not been amended since 2013; and

WHEREAS, on November 5, 2020, representatives of the City of Dayton and representatives of Columbia County met for the purposes of mediating possible terms of one or more new interlocal agreements for law enforcement services, dispatch services and municipal court services, to take effect on January 1, 2021; and

WHEREAS, the representatives agreed at mediation to certain terms and conditions, identified on the CR 2(A) agreement attached to this resolution, that each would present to its respective legislative body to be considered for inclusion in a new interlocal agreement encompassing law enforcement services, dispatch services, and municipal court services; and


WHEREAS, the City Council of the City of Dayton has reviewed and discussed the terms being considered for inclusion for a new interlocal agreement with Columbia County for law enforcement services, dispatch services and municipal court services; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DAYTON, WASHINGTON, as follows:


The City Council hereby approves the terms and conditions of a new interlocal agreement for law enforcement services, dispatch services and municipal court services as set forth in the CR 2(A) agreement attached as Exhibit A to this resolution. The City attorney is authorized to draft, in conjunction with Columbia County, an interlocal agreement for law enforcement services, dispatch services and municipal court services that memorializes the terms set forth in the CR 2(A) agreement attached as Exhibit A to this resolution. The mayor is authorized to execute and take such other action as is necessary to implement an interlocal agreement for law enforcement services, dispatch services and municipal court services memorializing the terms set forth in the CR 2(A) agreement attached as Exhibit A to this resolution.




CR 2(A) agreement

Pursuant to mediation on November 5, 2020, the City of Dayton and Columbia County have negotiated pursuant to CR 2(A) and each agree to present the following proposal to their respective legislative bodies for consideration:

- Five year agreement;
- One master interlocal agreement encompassing law enforcement services, dispatch services and court services: QnP ZW
- City will pay ~~\$600,000~~ ^{\$617,500} for 2021;
- Adjusted yearly on first day of January, starting January 1, 2022. Price increase at 100% of All Urban Consumers CPI, West Size Class B/C, All Items, effective January 1 of each year;
- The County and City department heads (or their representatives) will meet quarterly, and the county shall provide a quarterly expense reports;
- The sheriff will provide monthly reports to the City Council;
- The County will ensure there is a dedicated deputy sheriff in City limits at all times;
- Sheriff's Department will assist with tagging abandoned vehicles within City limits of Dayton




