ORDINANCE 1998

AN ORDINANCE AMENDING A PORTION OF THE 2022 BUDGET OF THE CITY OF DAYTON, AS ADOPTED IN ORDINANCE NO. 1970

WHEREAS, the City of Dayton adopted the 2022 Budget in final form by Ordinance 1986 on the _1st_ day of December, 2021; and

WHEREAS, subsequent thereto it has become necessary for the City to amend said budget because of revenue and expenditures that could not reasonably have been foreseen at the time of adopting said budget and the related ordinance; and

WHEREAS, amendments are necessary to reallocate funds across multiple funds to cover costs associated with various city expenses and to allocate additional revenues.

NOW THEREFORE, BE IT ORDAINED by the City Council of the City of Dayton, as follows:

Section 1. The following funds contained in the 2022 Budget is hereby amended to modify (*i.e.*, increase or decrease) revenues and expenditures by the amounts set forth below:

The Amended Fund ("Amnd Fund") column shows the final budget for each respective fund for the 2022 Budget year following the increase or decrease in revenues and expenditures as set forth above.

Section 2. A one-time transfer in the amount of from the City's general fund (001) to Hotel/Motel Fund (106) to cover an unanticipated over allocation to the Dayton Chamber of Commerce.

Section 3. The budget for fiscal year 2022 is amended to provide for the changes as outlined above, the amendment is hereby adopted, ratified and confirmed.

Section 4. This Ordinance shall become effective from and after its passage by the Council as set forth above upon approval by the Mayor, and after publication as required by law.
