#### **ORDINANCE NO. 2011**

AN ORDINANCE OF THE CITY OF DAYTON, WASHINGTON, AMENDING CHAPTER 1-1, SECTION 06 OF THE DAYTON MUNICIPAL CODE, DAYS AND HOURS OF OPERATION; PROVIDING FOR SEVERABILITY; PROVIDING FOR SUMMARY PUBLICATION BY TITLE ONLY; AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS,** Washington state law, as codified at RCW § 35A.21.070, requires that municipalities establish office hours by ordinance.

**WHEREAS**, the City of Dayton on July 8, 2020, adopted office hours with the approval of Ordinance No. 1965, codified at Dayton Municipal Code § 1-1.06 entitled "Days and hours of operation".

**WHEREAS,** the City Council of the City of Dayton has determined that the office hours established by Ordinance No. 1965 and codified at Dayton Municipal Code § 1-1.06 should be changed.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF DAYTON, WASHINGTON, DO HEREBY ORDAIN AS FOLLOWS:

<u>Section 1. City Office Hours.</u> Dayton Municipal Code Section 1-1.06, which currently reads as follows:

## 1-1.06. - Days and hours of operation.

The days and hours of operation of city hall will be from 7:00 a.m. until 4:00 p.m., Monday through Friday, except on days legally designated as holidays or at times of emergency. City hall shall post on or about the building entryway the days and hours of operation for the office.

## is hereby amended to read as follows:

## 1-1.06. - Days and hours of operation.

The days and hours of operation of City Hall will be from 7:00 a.m. until 4:00 p.m., Monday through Thursday, except on days legally designated as holidays or at times of emergency. City Hall shall post on or about the building entryway the days and hours of operation for the Office.

<u>Section 2. Scope of Revision.</u> Except as set forth in Section 1 of this ordinance, all other provisions of Dayton Municipal Code Chapter 1-1 remain unchanged.

<u>Section 3. Severability.</u> Should any section, paragraph, sentence, clause, or phrase of this Ordinance be held invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause, or phrase of this Ordinance.

<u>Section 3. Effective Date.</u> This ordinance shall take effect, and be in full force five (5) days after the date of publication.

<u>Section 4. Summary Publication.</u> A summary thereof of this Ordinance consisting of its title shall be published in the official newspaper of the City and shall take effect and be in full force five (5) days after the date of publication.
