A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF DAYTON, WASHINGTON AUTHORIZING THE MAYOR TO EXECUTE AN AMENDMENT NO. 2, CONTRACT NO. 11144 WITH THE WASHINGTON STATE DEPARTMENT OF CORRECTIONS TO EXTEND THE TERM OF SERVICES BEGINNING JULY 1, 2020 - DECEMBER 31, 2020

WHEREAS, the City's Master Contract Agreement with the Washington State Department of Corrections expired June 30, 2020; and

WHEREAS, the City received a request from the Washington State Department of Corrections to Amend the Master Contract Agreement on July 8, 2020 to extend the term of the Contract No. K11144 effective July 1, 2020 through December 31, 2020.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF DAYTON, WASHINGTON, HEREBY RESOLVES as follows:

Section 1. That the Mayor is hereby authorized to execute on behalf of the City of Dayton Amendment No. 2 to Contract No. K11144 extending the term of the Master Contract Agreement beginning July 1, 2020 through December 31, 2020 with Washington State Department of Corrections in the form attached hereto as Exhibit "A."

Section 2. That the Mayor or designee is hereby authorized to implement such administrative procedures as may be necessary to carry out the directions of this legislation.

<u>Section 3.</u> That this resolution shall take effect and be in full force upon passage and signatures hereon.


