RESOLUTION NO. 1451

A RESOLUTION OF THE CITY OF DAYTON, WASHINGTON, AUTHORIZING THE CITY ADMINISTRATOR OR HER DESIGNEE THE AUTHORITY TO LEGALLY BIND THE CITY OF DAYTON FOR THE SOLE PURPOSE OF REQUESTING FEDERAL REIMBURSEMENT FOR VARIOUS TRANSPORTATION PROJECTS

WHEREAS, the city administrator has been duly appointed by the City Council of the City of Dayton in accordance with Chapter 1-4A Dayton Municipal Code, which includes assisting the mayor in the performance of his duties and shall do all things required by the mayor or the city council to assist in the administration of the business of the city government, and shall oversee and supervise the various city departments as directed to do so by the mayor; and shall assist in the coordination and liaison of city business between the city council and the various city officers and departments; and

WHEREAS, the Federal Highway Administration, through the State authorizes federal transportation funding to the City for various transportation projects; and,

WHEREAS, the Code of Federal Regulations, 2 CFR 200.415(a) has been revised to ensure that final fiscal reports or vouchers requesting payment under Federal agreements must include a certification, signed by an official who is authorized to legally bind the non-Federal Agency; and,

WHEREAS, in order to seek timely reimbursement for proper expenditures related to the Federally funded grant projects, the City Council delegates to the person appointed as the city administrator the authority to legally bind the City solely for the purpose of requesting Federal Grant reimbursement.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF DAYTON, WASHINGTON, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. DELEGATION OF AUTHORITY. That for the purposes of requesting reimbursement for Federally funded transportation projects, the city administrator or designee shall be delegated authority per 2 CFR 200.415(a) to legally bind the City of Dayton in furtherance of the intent of this resolution; and,

SECTION 2. AUTHORIZATION TO SIGN. The that the person duly appointed as the city administrator or designee shall be authorized to sign all grant reimbursement vouchers for grant funded transportation projects on behalf of the City of Dayton in compliance with the 2 CFR 200.415(a) as follows:

SECTION 3. EFFECTIVE DATE. That this resolution shall take effect and be in full force upon passage and signatures hereon.
