A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF DAYTON, WASHINGTON, AWARDING THE CONTRACT FOR THE IMPROVEMENTS OF NORTH & SOUTH 3rd STREETS, J STREET, PEARSON STREET, AND MAIN STREET SIDEWALK PROJECT TO HUMBERT ASPHALT, INC.; AND AUTHORIZING THE MAYOR TO EXECUTE A PUBLIC WORKS CONSTRUCTION CONTRACT WITH HUMBERT ASPHALT, INC. FOR SAID WORK.

WHEREAS work to include . Overlaying approximately 1,600 linear feet of street reconstruction, 2,300 linear feet of street overlay, approximately 1,800 linear feet of water main replacement, approximately 4,100 linear feet of sanitary sewer replacement, railroad crossing improvements and pedestrian bridge reconstruction and other items, all in accordance with the Contract Plans, Contract Provisions, and the Standard Specifications.; and

WHEREAS the City utilized a competitive bidding process to obtain bids for the; North & South 3rd Street Improvements, J Street, Person Street and Main Street Sidewalk Project.; and

WHEREAS, after two bids were received and opened, Anderson Perry & Associates, Inc., determined, as prescribed by RCW 39.04.010, that the lowest responsive and responsible bidder was Humbert Asphalt, Inc. .; and

WHEREAS Anderson Perry & Associates, Inc., and City staff analyzed the proposal and recommends that Humbert Asphalt be awarded the contract as the lowest responsive and responsible bidder for North & South 3rd Street, J Street, Person Street and Main Street Sidewalk Project. Base Bid -, in the amount of \$,3,496,848.55 excluding applicable sales and use taxes; and

WHEREAS the City Council constitutes the legislative authority of the City of Dayton and deems the North & South 3rd Street Improvements, J Street, Person Street and Main Street Sidewalk Project to be in the best interest of the city.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF DAYTON, WASHINGTON, HEREBY RESOLVES AS FOLLOWS:

<u>Section 1. Bid Award.</u> The City Council hereby awards the public works contract for North & South 3rd Street Improvements, J Street, Person Street and Main Street Sidewalk Project in the form attached hereto as Exhibit A.

<u>Section 2. Authorization.</u> The Mayor is hereby authorized to execute the Public Works Construction Contract between the City of Dayton and Humbert Asphalt, Inc. in the amount not to exceed \$3,496,848.55, excluding applicable sales and use taxes for North & South 3rd Street Improvements, J Street, Person Street and Main Street Sidewalk Project.
