How Do I Notify the City of a Possible Code Violation?

Complaints can be filed by using the Request for Action Form, and sending it by email, mail, fax, or filling it out in person. A completed form must be included with the following information: your name, phone number and address, the exact street address where the possible violation has occurred and specifics regarding the violation before city compliance officer will investigate.

Weeds, foliage, grass, shrubs, or other vegetation that constitutes a fire hazard, or encroaches on sidewalks, alleys or neighboring properties, is damaging public improvements, or subjects neighboring residential properties to weed growth.



The City of Dayton works hard at trying to maintain our streets. The presence of any obstruction on the streets, alleys, or public right-of-ways can make it difficult for them. Low-overhanging trees and overgrown shrubs or other plants need to be maintained to prevent them from being a nuisance.

Obstructions to the public right-of-way. Use of property abutting a public street or sidewalk or use of a public street or sidewalk which causes any obstruction to traffic or to open access to the streets or sidewalks; provided, that this subsection shall not apply to events, parades, or the use of the streets or public rights-of-way when authorized by the city. This section includes the existence of drainage onto or over any sidewalk, street or public right-of-way, and the existence of any debris or plant growth on sidewalks adjacent to any property

During the summer months it can be hard for some to keep up with their weed and grass problems. It is important for us to try to keep these areas maintained. Tall grass and weeds are a common place for vermin, such as rats and mice, to use for corridors to enter buildings or residences.

Fire is also a major concern when these grass and weed areas become dry.
