



APPLICATION FOR PEDDLER/SOLICITOR LICENSE

This license is required under the Dayton Municipal Code, Section 3-5. Applicants must allow 10 business days after application is received for the purpose of investigating the applicant. There is a fee of \$50.00, made payable to the **City of Dayton** at the time of application. Provided, however, that the applicant desiring to obtain licenses for more than one individual shall purchase additional permits for \$15.00 per additional applicant. *Each individual applicant must complete an application prior to operating within the City of Dayton.* Licenses expire annually on December 31st of each year.

Complaints of illegal or aggressive sales tactics reported to the City of Dayton from residents will be immediately forwarded to the Attorney General Consumer Protection Office and the Columbia County Sheriff's Office.
