Action: Bailey makes a motion to the Council to consider Ordinance No. 1251, authorizing a 1% increase in the regular property tax levy pursuant to 85.55

RCW. Kaczmarski seconds the motion. Hall had some questions on the math of the percentage per household. Motion carried unanimous.

7. NEW BUSINESS

Action:

Council was presented the 2014 Comprehensive Plan Amendments by Karen Scharer, Planner. Scharer explained the amendments. Nysoe makes a motion that the council tables this decision until the next meeting given the amount of information that they received. Hall seconds the motion. Motion carried unanimous.

Action:

Bailey makes a motion to Approve Memorandum of Understanding with the Council 2, Washington State Council of County and City Employees, Local 1191-CD for a cost of Living Allowance effective Jan 1, 2015 – Michael Paris Chairman of Personnel Committee explained in detail the increase of 2.25%. Mayor George explained the cost of living increase and AWC's standards of like positions. Nysoe had questions on the time frame of the increase. Hall asked what the State has approved as far as pay increases. Paris explained negation process the committee went thru. Kaczmarski seconded, Motion carried 5 -1 with Hall voting Nay.

Action:

Paris makes a motion to Approve Resolution 1252 Authorizing December 26th, 2014 as a Council Discretionary Holiday pursuant to Resolution 1149, 2008 Personnel Policies and Procedure, Chapter 6, Section 4- Legal Holiday. Nysoe seconds the motion, Motion carried unanimous.

Action:

Bailey makes a motion to Approve Ordinance No. 1868, amending the 2014 Budget to account for unanticipated revenues resulting in unanticipated expenditures. Mayor George explains the amendments. Berg seconds the motion, Motion carried unanimous.
