# 3. ADOPTION OF MINUTES

- A. January 17, 2018
  - a. Butler motion to approved minutes as presented; Lane second. All in favor none opposed. Motion carries.
- B. February 7, 2018
  - a. Butler motion to approved minutes as presented; Talbott second. All in favor none opposed. Motion carries.

#### A. Re-appointment:

a. Butler motion to reappoint Smith for a second term. Lane second, all in favor. Smith will be officially reappointed at the next City Council meeting on March 14.

- a. Commission Chair
  - i. Butler nominated Talbott as commission Chair. Talbott accepted.
  - ii. Butler motioned to elect Talbott as chair. Lane seconded, all approved.
- b. Commission Vice-Chair
  - i. Butler nominated Smith as Vice Chair. Smith accepted.
  - ii. Butler motioned to elect Smith as Vice Chair. Talbott seconded, all approved.

#### A. Pietryzcki Park Sign Options – Michael Smith

a. Smith is waiting on more information and requested item be tabled until next meeting.

#### B. Review of Historic Preservation Code Update: Section 8

- a. Made a brief review of sections 1-7 to approve previously unapproved minor edits.
  - i. Minor edits were unanimously approved.

- ii. Agreed to change Section 7C.b to require a minimum of 51%, rather than 60%, property owner approval for a group to nominate their properties as a district.
- b. Reviewed Section 8 updates.
  - i. Minor edits were unanimously approved.
  - ii. Discussion regarding the placement of Special Valuation was held. Staff will present recommendation to Commission prior to a decision being made, whether being within the code or adopted in the Bylaws.
  - iii. Agreed to add definitions for Administrative Certificate of Approval (ACOA) and Administrative Advisory Review Certificate (AARC) to Definitions in Section 4.
- c. Bailey introduced the DHPC Bylaws with initial updates and requested commission members review Sections 1 and 2 for the next meeting.
  - i. Commission agreed to streamline Bylaws by referring to code when applicable, rather than duplicating information.

- a. Butler motioned to adopt Findings of Fact 2018-002 Bartlett Sign. Lane seconded, all approved.
- b. Butler motioned to grant Condition of Approval 2018-002 Bartlett Sign. Lane seconded, all approved.
